



## Netherton Infant and Nursery School Remote Learning Plan September 2020 (Updated January 2022)

In order to ensure that learning is continued, irrespective of lockdown and self-isolation, Netherton Infant and Nursery School has developed the following plan. This plan offers remote learning opportunities whilst also acknowledging that some households have limited access to devices and would require hard-copies of work and resources.

This plan will be applied in the following instances:

- 1. An individual is self-isolating because of a positive test within the household or is awaiting the results of a test;
- 2. A group of children are self-isolating because of a case of Covid19 in the bubble;
- 3. A whole bubble or cohort is self-isolating because of an outbreak of Covid19
- 4. Children are home learning due to a national lockdown

The plan complies with the expectations and principles outlined in the DFE document <u>Guidance for Full Opening of Schools</u>. This plan also adheres to the safeguarding policies of the Together Learning Trust with regard to online learning and data protection.

## Software and online platforms

Within all plans, teachers will set appropriate work in-line with our current curriculum, primarily supplemented by a range of resources provided by Oak Academy, White Rose Maths, Little Wandle and PurpleMash.

Children will remain in contact with their class teacher or support assistant through Google Classroom (to share successes and communications).

Oak Academy has been selected to support remote learning. The online lessons are free to all and offer a recorded taught session so that the children can access physical teaching from a teacher and then access work relating to that lesson within the same website. There are also hundreds of lessons specifically aimed at children with SEND needs and requiring additional support.

White Rose Maths resources will also be used as they are matched to our current maths curriculum model. Children are very used to seeing these resources.

In the event of any form of isolation and loss of learning caused by Covid19, parents must understand that engagement in home learning is compulsory, as is the expectation that Netherton Infant and Nursery School makes that provision available and accessible to all. However, if children themselves are too ill to attend then they should not be expected to engage in home learning.

## **Remote Learning**

The initial response to any isolation will be to provide children with home learning materials. In the case of whole cohort isolation, interim resources will be uploaded to Google classroom and some children will have packs delivered. This measure will afford teachers a short time to prepare their remote learning resources.

Using Google Classroom, the Class teacher will upload worksheets at 8am, where possible, on the day to allow parents to see the learning materials prior to supporting their child. The teacher will decide what materials are most appropriate for the individual child.  There will be phonics (where appropriate) or grammar (Y2), reading, English, maths each day and a range of foundation subject activities for the week. This will be in line with what is being taught in class to ensure consistency.  Hard copy of learning sent out if the child cannot access online provision. Parents can communicate through Google Classroom in the first instance and any additional learning can be attached and sent through via email if necessary.  If a child is isolating for a short time while awaiting test results, they will continue with the hard copy of the learning they left school with. During a national lockdown, with DfE support, the voucher scheme will be initiated. If necessary, we will contact Local Welfare Provision to ensure a replacement is made available.  If child is vulnerable in any way, the DSL will ensure that appropriate agencies are notified and arrange for regular safe and well checks via a phone call from the DSL (record on CPOMS).  If a child does not engage, a member of staff will contact parents to discuss obstacles and support.
